DIRECTIONS TO THE GROUNDS

Detroit Beagle Club is located at 10100 Cement City Highway, Addison, MI (a dirt road) approximately two miles east of US127, and two miles south of US12.

From East or West, take US 12 to Cement City Highway which is approximately 2 miles east of US 127.

From North, take US127 (in Jackson) south to US12, turn left, go two miles to Cement City Highway, turn right (south).

From South (East of grounds) on US23, go north to US 12, then west approximately 2 miles to Cement City Highway.

From South (West of grounds) go north to US12, turn right (east) to Cement City Highway, turn right (south).

From South (SHORTCUT) From US23 go NW on US223. Just North of Adrian, turn right on DEVILS LAKE HIGHWAY. Turn left on Heath road. Turn right on Cement City Highway and The Detroit Beagle Club will be on your immediate Left side.
