

ADDITIONAL INFORMATION

BEATING BRUSH – Everyone needs to contribute to the success of the trials in some way. Beating brush is an essential part of field trailing, and the trial cannot be conducted without brush beaters. Everyone physically capable of beating brush is expected to take their turn.

DRESS – It is recommended that sturdy shoes or boots and durable clothing be worn. Bring appropriate gear, as the trial will be run rain or shine.

ENTRIES – Pre-entry will NOT be accepted for these trials. Entry forms must be complete, legible, and submitted on a regulation 5 ½" x 8 ½" form. A separate entry form and payment must be submitted for each dog for each trial entered. All dogs are to be present on grounds when entries close to be officially entered. NO MULTIDAY ENTRY PAYMENTS. checks payable to WDC. Handler of a dog that kills or injures a rabbit on grounds under any circumstance shall pay \$25.00 Owners and handlers are responsible for their dog at all times on the grounds, dogs are dogs respect your close neighbor and their dogs in and out of the field, dogs can get excited in the hunt!

FOOD – Breakfast and Lunch will be available for purchase at the grounds. **\$6.00** for Breakfast & **\$8.00** for lunch. We would greatly appreciate if you could let us know if you will be having meals (with the cost of food we would like to have enough but not buy too much!)

GROUNDS – The grounds will be available for set up after <u>2pm on Thursday October 19, 2023</u>. Please keep your set-ups clean, pick up after your dogs and do not leave trash (including baggies, water bottles, etc.) in the field trial grounds.

ALL dogs MUST be on lead or secure in ex-pens /crates except when under judgement during the trial. It is strongly advised that no dogs be left unattended in ex-pens.

HARNESSES – The AKC rules are silent regarding the use of body harnesses. As a result, body harnesses will only be allowed if the handler receives advanced permission of both judges for the class. If the harness is allowed by the judges, the harness must be well fitting with nothing hanging from it and with no attachments other than tags for identification purposes and the harness MUST remain on the dog the entire time the dog is under judgement.

MOTORIZED VEHICLES – Only motorized vehicles utilized by the club will be allowed in the field.

PRACTICE – NO practice on the grounds will be allowed.

TRACKING COLLARS – If needing to use a tracking collar during this field trial event – ONLY AKC approved tracking devices are allowed in AKC Field Trials and Hunting Tests. Please alert the host club the morning of check-in before role call for each event day and MUST have permission from judges from the day's event to use.
